PURCHASE OF 25 Nos OF LAPTOP FOR THE USE OF ANIMAL HUSBANDRY DIRECTORATE, THIRUVANANTHAPURAM.

Sealed and competitive tenders are invited from the manufacturers/ authorized dealers or suppliers of computers / laptops having service centres within Kerala State, under the "Two cover system" for the supply of Purchase of 25 Nos of Laptop for the use of Directorate of Animal Husbandry, Vikas Bhavan, Thiruvananthapuram for the year 2024-25.

First Cover (Cover A - Technical) should have the following enclosures:-

- 1. Detailed Specification of item, without rate and with the list of institutions where supply has to be effected. The make of the item quoted should be mentioned.
- 2. Original or attested copy of manufacturing license in case of manufacturer. Original or self-attested copy of trade license in case of suppliers.
- 3. All documents furnished should be attested by a Gazetted Officer or a Notary.
- 4. A declaration of the supplier/ manufacturer making the supply of the materials to the effect that the supply of the materials will be done within 30 days from the date of receipt of the supply order.
- 5. Catalogues with photographs with detailed specifications of the quoted item should be produced.

- 6. A copy of the ISO/BIS certificate if any, shall be produced.
- 7. GST certificate.
- 8. An affidavit in Rs.200 Stamp paper Notarized by a Notary public of either, the place where the person making the affidavit is residing or of Thiruvananthapuram, signed by a responsible person of the firm (Managing Director or Director) specifying his status, age, residential address.
- 9. Name, address, RTGS/IFSC code of the bank with which, the firm holds financial transactions. A scanned copy of a cancelled Cheque leaf should also be uploaded.

Second Cover (Cover B -) should have the following enclosures:

- 1. Rate should be quoted as basic price, rate of tax, and total amount.
- 2. Details of EMD paid (1% of the total cost of item quoted).
- 3. Preliminary agreement in Rs.200/- Kerala stamp paper.
- 4. Original tender form duly signed by authorized signatory.

Both Technical bid and Financial bid documents must be effectively uploaded. Technical bid and Financial bid will be opened as per the schedule given below. Financial bid of those tenderer who satisfy the conditions in the Technical bid will only be opened.

The tender form for the supply of 25 Nos of Laptop for the use of Directorate of Animal Husbandry can also be had from the Animal Husbandry Department website www.ahd.kerala.gov.in. The intending tenderer may send the exact amount towards the cost of tender form online. Cash, Cheques, Postage Stamps, Postal Orders, Demand Drafts, etc. will not be accepted as the cost of tender form nor shall the form be sent by Value Payable Post.

Late tenders will not be considered under any circumstances.

The rates quoted should be as basic price, rate of tax & total amount.

- 1. All offers should be in the original packing of the Manufacturer/Supplier.
- 2. Firms blacklisted in Kerala State or other States cannot participate in the tender.
- 3. The Security Deposit (5% of order value) should be furnished as Account Payee Demand Draft/Bank Guarantee from a nationalised Bank (valid upto the risk liability period) or Treasury Deposit and will be released only after satisfactory completion of the contract.
- 4. The rates should be for delivery on F.O.R. (Freight on Road) basis in any part of the State.

- 5. Ex-go down rates and 'F.O.R. station of dispatch rates' offered by the firms are not acceptable and such tenders will be summarily rejected.
- 6. The quantities specified in the schedule are only approximate and they may vary according to actual need and availability of funds.
